## 1. Agreement to Terms

Each project proposal will specify the number of included revision rounds. Revision requests beyond the included rounds will be billed at our standard hourly rate. Major scope changes may require a revised proposal and additional fees.

## 5. Client Responsibilities

You agree to:

- Provide all required content, images, logos, and materials in a timely manner.
- Review and provide feedback on deliverables within the agreed timeframe.

- Ensure you have the right to use any content, images, or materials you provide.
- Pay invoices on time according to the agreed payment schedule.

Delays caused by the client's failure to provide materials or feedback may result in project timeline extensions or additional fees.

## **6. Intellectual Property**

Upon receipt of full payment, you will own the final website design and content created specifically for your project. We retain the right to:

- Display the completed project in our portfolio.
- Use general design techniques, code structures, and methods in future projects.
